Please note it is important for collectors to submit the Electronics and Paint Collection Funding Request Forms (Funding Requests) after each shipment or at least on a monthly basis. This allows for quicker follow up and corrections on any issues, which may otherwise delay funding payments.

Please note that if you miss a quarterly *Collector Funding Request Due Date*, the Funding Request can still be submitted as part of the next quarter prior to yearend.

All funding requests for shipments up to the year end, March 31, 2021 are to be submitted no later than April 15, 2021 in order to be eligible for funding payments.
