This document provides compliance guidance to producers on hazardous and special products (HSP) that they are required to report by material type under Part 2 of the *Extended Producer Responsibility Regulation*, AR 194/2022 (EPR Regulation). As established in the EPR Regulation, materials subject to the Designated Material Recycling and Management Regulation, AR 93/2004 and Part 1 of the EPR Regulation are excluded from HSP.

The following table provides definitions and examples of included HSP by material type.

In identifying which material type a producer's product might fit in, producers should classify their product based on the following hierarchy:

1. Single-use batteries
2. Rechargeable batteries
3. Pesticides
4. Pressurized container that contains a flammable, corrosive or toxic gas
5. Order of preference as established in the Transportation of Dangerous Goods Regulations (TDGR)
  1. Flammable
  2. Corrosive
  3. Toxic
